Dear Members of the Council and the City Manager:

WHEREAS, the Daniel F. Burns Apartments at 30-50 Churchill Avenue in North Cambridge, Massachusetts is a public housing project of the Cambridge Housing Authority with 198 apartments explicitly for the benefit of the elderly and persons with disabilities; and

WHEREAS, a large number of the resident tenants regularly have medical and other service personnel coming to their apartments throughout the week; and

WHEREAS, many of these medical and service personnel are not residents of Cambridge and therefore have no permit to park within a reasonable walking distance of the Burns Apartments; and

WHEREAS, the City of Cambridge does not grant non-resident parking permits to agency staff who are providing services to the elderly and persons with disabilities; and

WHEREAS, other cities and towns in the immediate vicinity do issue non-resident parking permits for agency-based medical and service personnel who are making home visits;

NOW THEREFORE, we the undersigned residents of the Tenants Association of 30-50 Churchill Avenue in the City of Cambridge petition the City Council and the City Manager to make available to the agencies of medical and service providers some version of non-resident parking permits during the day, Monday through Saturday, for those staff who visit the elderly and persons with disabilities in their homes.
