

Dear Neighborhood Representative:

This office is in receipt of a copy of an application from Gautam and Victoria Khanna requesting a curb cut at the premises numbered 242 Lakeview Avenue, Cambridge, Massachusetts. The City Council has directed that all curb cut petitions be submitted to the appropriate Neighborhood Associations for the locality where the curb cut would be made, so that the association may have an opportunity for review, prior to action by the City Council.

However, I urge you to make every effort to complete your review as soon as possible.
