





Alvin Helfeld's talk to the Cambridge City Council - 10/20/2014

1. Hello, my name is Alvin Helfeld. I have lived at 417 Concord Ave, 3 houses down from Fern St., for 34 yrs. and I ride my bike daily except in the winter.
2. On 9/5/14, at the block party given by the city contractors, I saw the Arts Committee's plan for Fern St.
3. I discovered to my amazement that the plan eliminated all 18 parking spaces on Fern St.
4. I was very upset by this and spoke to several neighbors.
5. I went home and wrote up a petition for a compromise plan that included a pedestrian path, a two-way bike path, single vehicular lane and a parking lane on the left side (west), safely away from the bike lanes.
6. I started this petition because I believe that the plan itself and the process of developing this plan have some serious mistakes. **351 residents** have signed this petition.
7. I spoke to a number of people and I would like to briefly summarize the process: The city approached Fern St. with several agendas: 1. Eliminate all the parking, 2. Make Fern ST a site for an Art Project, 3. They set up a committee of people who were either chosen by the city or were self-selected.
8. We believe there were several serious mistakes: 1. City assumed that because there were no residents living on Fern St, the neighborhood didn't care about it; 2. The plan was created by a group of people who did not represent the surrounding neighborhood; 3. This committee made a crucial decision for the neighborhood, removing 18 parking spaces, without getting feedback from the surrounding neighborhood; 4. It is one thing for a committee to choose trees and art; it is another thing for a committee to make a drastic decision that will disrupt people's lives.
9. Who uses Fern St? 1. Residents without off-street parking routinely use it for overnight parking. 2. Parents who attend Little League games, 3. Residents who cannot park on Concord Ave during snow emergencies and when piles of snow reduce parking on neighboring streets; 4. On street sweeping days. Fern St serves as a safety valve for all of these occasions.
10. The plan offered by the Fern St. petition is a very good compromise with the present city's plan. Our plan provides for pedestrian and bike riding safety, attractiveness and art with the availability of 18 parking spaces.



Hi Alvin,

I saw your Fern St petition on the Tobin listserv.

I participated in the public art review process last spring (before the FPRA really took root) and did not like any of the 3 designs -- but the committee was told we had to pick one of them. Kathy Watkins and others from DPW were there. No one talked about the impact on parking but the clear intent was to turn the street into more of a pedestrian and bike passage between Tobin and Danehy and to slow and limit traffic by adding curves -- parking never came up because the committee was only concerned with evaluating the "artistic" qualities of the proposals to decorate the sidewalks. I inferred that the street plan itself had already been approved by the higher ups in the broader context of the sewer project. To me, the whole decision making process was rather strange (the meeting ran 4 hours). It was supposed to take place in Feb but got snowed out and by the time we met in April there seemed to be a great rush to get something approved. Everyone agreed the final choice still needed work and the public art association was supposed to work on it with the artists through the summer. I never heard another word.

I wanted to let you know we are holding an FPRA meeting on Wed 9/10 at 7 at Tobin -- if you want to bring your petition and say a few words that is fine. It's another example of an imperfect "public" process. There are also environmental issues (soil contamination) on Fern St that demand close supervision with all the digging.
