

PEACE BE UNTO YOU: (3/2/15).

I'M HASSON RASHID, RESIDE AT 820 MASSACHUSETTS AVE, PUBLIC COMMENT TODAY IS IN REGARDS TO AGENDA ITEMS (UNFINISHED BUSINESS I# 15, POLICY ORDER AND RESOLUTION LIST I# 2).

THE FOUNDRY BUILDING (FB) IS A SUITABLE CITY OWNED PROPERTY, A VACANT FACILITY, CATEGORIZED AS UNDERUTILIZED, EXCESS OR SURPLUS, AND I GO ON RECORD STATING, THAT IT SHOULD BE DONATED FOR THE PURPOSE OF ASSISTING AND HELPING, OUR HOMELESSNESS SECTOR AND MOSAIC.

OUT OF THE INITIAL FOUR OPTIONS TO COMMENCE FB PLANNING AND DEVELOPMENTS, ONE WAS CHOSEN, IT PROPOSED TO NAME THE CAMBRIDGE REDEVELOPMENT AUTHORITY (CRA), TO STEER FUTURE FB PLANNING, DEVELOPMENTS, AND RECOMMENDATIONS. THE LIVING RECORD DEMONSTRATES, THAT IN THE PAST, AND UP UNTIL THE PRESENT, THE CRA HAS NEGLECTED AND CIRCUMVENTED, THE LEGITIMATE RIGHTS OF THE POORIST OF THE POOR, TO BE INCLUDED IN ITS FUTURE ORIENTATED PLANNING, DEVELOPMENTS, AND RECOMMENDATIONS. NOT ONLY THE CRA IN ITS PLANNING, DEVELOPMENTS, AND RECOMMENDATION, FOR THE SO-CALLED INNOVATIVE ECONOMIC WELL BEING OF THE CAMBRIDGE REGION, BUT FEDERAL, STATE, REGIONAL, AND LOCAL COMMUNITY ENTITIES IN THEIR PLANNING AND RECOMMENDATIONS, ARE ALSO GUILTY OF BEING INSENSITIVE, IN INCLUDING THE ON GOING HOUSING AND HUMAN SERVICES NEEDS, AND RIGHTS OF OUR HOMELESSNESS SECTOR AND MOSAIC.

LOOK AT THE VOLPE AND SULLIVAN COURT HOUSE BUILDINGS, NOT A CRY OR CONCERN, WAS HEARD IN OUR COMMUNITY, BEING OFFERED ON BEHALF OF OUR HOMELESSNESS SECTOR AND MOSAIC, BY ANY OF THE MENTIONED ENTITIES. C2/K3, CAMBRIDGE CONVERSATION, MASTER PLANNING, NO ONE BUT MYSELF WENT ON RECORD UTTERING WORDS ABOUT INCLUSION OF OUR HOMELESS POPULATION, IN FUTURE PLANNING, DEVELOPMENT, OR RECOMMENDATION AT THE FB. THE HOMELESS SECTOR AND MOSAIC, MUST BE INVOLVE IN ALL PHASES OF FUTURE PLANNING, AT THE FOUNDRY BUILDING AND OTHER EXCESS OR SURPLUS GOVERNMENT PROPERTIES AND FACILITIES LOCATED IN CAMBRIDGE, MA, TO AVOID ANY FURTHER MISTAKES BY POORLY GUIDED GOVERNMENT, AND OTHER LOCAL PLANNING, DEVELOPMENT, RECOMMENDATION ENTITIES, AND ESPECIALLY AT THE FOUNDRY BUILDING.

THIS INSENSITIVITY, IN REGARDS TO THE LEGITIMATE NEEDS AND RIGHTS, OF OUR MOST VULNERABLE POPULATION, THE POORIST OF THE POOR, MUST BE STOPPED AND CORRECTLY ADDRESSED, AND ALLOWED THE CHRONIC HOMELESSNESS SECTOR AND MOSAIC, THE LEVEL OF PRIORITIES, NEEDS, AND RIGHTS IT TRULY DESERVE. THANK YOU.
