

Notice is hereby given that A-Ace Boston Cambridge Express, Inc. has applied for a Jitney License to operate a shuttle service. to operate seven days a week, from 6:00 a.m. to 2:00 a.m. The route will be circular from Logan Airport to Cambridge hotels every twenty to thirty minutes. Service will provided by two vans, which will have 14 seats and one seat will be removed for luggage. Vans will be garaged in Lynn, MA, using the following amended route not yet approved by the License Commission.

Revised Cambridge Routes

Leave Logan Airport on route 1-A to Sumner tunnel; leaving tunnel follow signs for Storrow Drive; Follow signs for Leveret Circle route 28: Go over Charles River Bridge and past Museum of Science; Take a left on to Land Blvd: Follow to second light and take a right on to Binney Street: Binney Street turns into Galileo Galilei Way: Take a left onto Broadway; Pull into the **Marriott Residence Inn**; Leave taking a right out of the driveway; Follow Broadway to the **Marriott Cambridge**; Take a right out of the driveway; And an immediate Right onto a driveway that leads to Main Street behind the hotel; Follow Maine Street to Vassar; Bear left onto Vassar; Follow Vassar to Mass. Avenue; Take a right onto Massachusetts Avenue; Go about a half a mile to Sidney; Take a left onto Sidney to Green Street; Take a left onto Green Street; Stop at the **M.I.T. Hotel**; Take a right back onto Green Street; And a left onto Lansdowne Street; And a left onto Mass. Avenue; Follow Mass. Ave. into Harvard Square; Follow Mass. Ave. out of Harvard Square to Shepard Street; Take a left on to Shepard Street; Follow to send @ Garden; Take a left on to Garden; Follow Garden and stop at the **Sheraton Commander**; Continue down Garden To Mass. Ave.; Take a right on Mass. Ave.; And a right on Elliott Street; Follow to J.F.K Street; Take a right on J.F.K. Street; Follow down and over the river take a left on Storrow Drive to Mass. Pike and back to Logan.
