



The STATE SEAL, adopted by Governor John Hancock and the Council on December 13, 1780 and made official by the General Court on June 4, 1885, is circular and bears a representation of the arms of the Commonwealth encircled with the words, "Sigillum Reipublicae Massachusettensis" (Seal of the Republic of Massachusetts).

I demand a change in consciousness, immediate removal of State seal and Flags, we expect more from the Leaderships of Cities and Towns of Massachusetts.

## FOUNDATION PRESIDENT REVEREND DANNY DE GUG AMENDS SUFFOLK SUPERIOR COURT LAW CASE TO INCLUDE 45,000 ACRES OF LAND.

The Plaintiff in the Suffolk Superior court case of honoring our Root Peoples of Massachusetts in particular and our Indigenous Natives in the Western Hemisphere is Reverend Danny De Gug. He created a Seminary of Interfaith that works to better the world of religion in regards to fair play. He ordains men and women that seek to fulfill their potentials; simultaneously all ordained keep their personal traditions, heart's treasures and faith.

Likewise Reverend Danny De Gug works in this lawsuit to assist the Root People, our Mothers and Fathers of the Land. Our Root People aka our Native American Indians, need to accomplish and reach their new Renaissance, to rediscover their treasured land and to make known their true identities.

The court case **is now** amended to include 45, 000 acres of prime recreational land out of 500,000 acres that the State presently controls. The Reverend states "In order for Massachusetts to really celebrate Thanksgiving it ought to look at the mere 300 plus acres that Scrooge left for their Root Mothers and Fathers on the Mainland" [Massachusetts has a land area of about **5,019,113.6 acres**]

Reverend Danny De Gug states " I am now set on the stage of a living drama in Massachusetts Suffolk Superior Court. The court case involves the racist and violent imagery by White Supremacists of the period of 1780. Before and after that period of time, even **today** such an odious Massachusetts flag waves defiantly against our human rights" Recall an offense against one ethnicity is an offense against us all. Present day leaderships in Massachusetts have sustained the puzzling symbol of Massachusetts.

Plaintiff Reverend De Gug explains, "It, the seal and flags are now unmasked and exposed by investigating reporting and intellectual proof. The beast exposed is the law system, Bull Romanus Pontifex, and its offspring the Doctrines of Discovery and Manifest Destiny. This beast and offspring betrayed our Root People by that so call judicial system; it created a Kangaroo court to be one-sided, stole their identity and genocide them".

One needs to read this article and more in order to fully grasp the dimensions of history and present day political controls to see why Reverend De Gug is taking to task Attorney General Coakley, Secretary of State Galvin and Governor Deval Patrick on charges of sustaining intimidation, prolonging racism and holding up a symbol of ridicule that is full of political and social scandal toward our Native People.

In 1780 the state seal was etched and made a presence in document ratifications.

Reverend De Gug points out: " It, the 1780 engraving, seal, is a well nigh perfect reflection of today's flag and seal. Yet the underprivileged and genocide Native American Indian community of Massachusetts in particular and in general the Western hemisphere had endured and now suffers the looks of such a violent, genocidal and racist sword and arm over a person of color and Native Ethnicity".

"Yes, the State flag has the Arm of a known wrongdoer, Myles Standish, who is recorded as the Leader of a merciless massacre of Native Indians in Massachusetts. In the etchings and on the Flags of even today is that murderer's racist Arm and Sword in a ready to strike position, which in fencing is known, as the "Cutting Position"

**Recently, John Bach, leading resident Quaker of Cambridge Friends Meeting commented:**

"As a Quaker, I come from a long tradition of recognizing the inherent worth and dignity of all people. I am troubled by a state seal and flags which ignored and ignores centuries of cultural annihilation and holds up an instrument of war with which to seek a savage and ironic "quiet peace under liberty."

The Reverend Danny De Gug has created the most innovative and a highly gifted Art Program to honor our Root Peoples of Massachusetts and the entire Western Hemisphere. It will be launched when the court compensation is received. Reverend De Gug states" I personally will never receive any compensation from our settlement on this matter.

Plaintiff Reverend Danny De Gug repeats: The court case **is now** amended to include 45,000 acres of prime recreational land out of 500,000 acres that the State presently controls.
