Hi Mike & Dennis,

Caesar gave me your e-mail addresses and suggested I send this to you.

The Sprint store next door to your restaurant wants to put up a small (18"x18") non-illuminated projecting sign.

Part of this process is that it needs to go before Cambridge City Council for approval (you may have gone through the same process for your awning) and as part of the City Council application, sign-off from the abutters is required.

I've attached a copy of the sign off sheet for your review and signature, there's a section where you can indicate your approval or disapproval of the sign. There's
