- 4) How can we encourage more entertainment /cultural events? : The committee recommends that:
 - a) Work closely with the Arts Council on new ideas and events
 - b) Re-write the language on entertainment in the rules booklet –Question on details of this suggestion and being more flexible on allowing applications
 - c) Work closely with organizations in the city to encourage events
 - d) Require a security plan from the group holding the event
 - e) Provide a list of available venues
 - f) Look into zoning issues for an entertainment district
 - g) Encourage existing restaurants to hold one day entertainment events
 - h) Encourage local talent and artists to use local venues
 - i) Keep in mind the concerns of local residents, noise and parking issues.
