The following Question was asked and answered:

Question: The facilities manager walked us through two additional areas that were not listed on the locations section of the specifications (Shift commanders Office and Record Keeping Office wall area). Should we assume these areas have been added to the locations section or will there be an addendum sent out for the scope of work?

Answer: Yes these two areas are additional to the specifications. One office space 12x12 approximately 144 sq. ft. and a wall 14x12 approximately 140 sq. ft. Estimated total additional space is 284 sq ft

Question: It was also discussed that 2 coats of finish paint are preferred on all wall areas should we assume this will be the case for the project?

Answer: Yes one primer and one finish coat
